Counsel appearing for the respondents no. 3 and 4, the matter can be referred to the SFIO through Ministry of Corporate Affairs for a detailed investigation into this case as many allottees have been duped of their money. Forensic report so far procured by the RP shall be forward as reference alongwith the complaint to the MCA/SFIO.

Respondent no. 5, one of the Ex-Directors is present in Court. He is directed to cooperate fully with the RP and/or give details of documents or in whose custody they would be available with. Respondent no. 5 submits that he has already cooperated with the RP, a fact which is being confirmed by the RP. He also submits that he has been present in court on each and every date and therefore, he prays that bailable warrants be discharged. As even today, he has appeared before this Bench. Accordingly, the bailable warrant stand satisfied and discharged.

The RP is directed to ensure that all allottees as per list be provided by the respondent are notified about the resolution process.
